Trade Notice No: 06/2018 – Mandatory Utilization of Centralized Port Reception Facility Portal : Swachh Sagar reg.

Ref : Director General Of Shipping Circular No. 06 of 2018, Utilization of Centralized Port Reception Facility Portal : Swachh Sagar dated 20th Nov 2018.

This is to inform you that as per Director General Of Shipping Circular No. 06 of 2018, Utilization of Centralized Port Reception Facility Portal : Swachh Sagar is mandatory for all Indian ports and all vessel visiting any Indian port, anchorage, roadstead etc whether or not port reception facility is required effecting from 1st December 2018.

In view of the above, it is requested to complete online "Advance Notification Form" on Swachh Sagar portal <http://prf.irclass.net/anf> available on DGS website by all vessel visiting Dhamra port, anchorage, etc. whether or not port reception facility is required effecting from 1st December 2018 as per below requirement.

- All ships visiting Dhamra port or anchorage should access the web portal and give details as stated there including inventory of ship generated waste on board whether or not a port reception facility is required.
- If the ship is at anchorages such details are to be filled up weekly.
- In case port reception facilities are required, then the same is to be preferably requested 24 hours or more prior arrival.

Dhamra Port authority will deny entry of ship in ports jurisdiction in case of non-compliance, that is, in case requisite data is not filled up in the "Advance Notification Form" available in the portal whether or not port reception facilities are required.
